The Bhutan Food and Drug Authority (BFDA), Ministry of Health (MoH) is pleased to issue the Conditional Clearance to Mr./Ms.CID no. fromvillage, geog, dzongkhag for the establishment of the meat shop.

This conditional clearance is subject to the following terms and conditions:

- The holder shall ensure that this clearance is valid only for the establishment of a meat shop at village, geog, dzongkhag/Thromde and not for any other purpose and at any other place.
 - The scope of this clearance is limited to the establishment of a (retail/wholesale/cold storage) meat shop and not for the clearances required by other stakeholders.
 - The holder of this clearance shall comply with the BFDA Criteria for Good Hygienic and Manufacturing Practices.
 - The holder of this clearance shall ensure that the proposed activity is implemented in line with the Livestock Act of Bhutan 2001 and the Livestock Rules and Regulations of Bhutan 2017 or any other food safety norms in effect.
 - Failure to comply with the standard requirement for the establishment of a meat shop shall be dealt as per the provisions of the Livestock Rules and Regulations of Bhutan 2017
 - After setting up the meat shop establishment completely, the holder of this clearance must approach the BFDA office concerned for final inspection and to obtain operational clearance to start a meat shop.
