- 2. Valid Trade License
- 3. Sample Label of the product
- 4. Evidence of the manufacturer meeting the food safety regulatory requirements in their respective country of origin (eg. FSSAI License, food safety management system certifications, etc.)

General Entry Conditions:

- 1. The consignment of milk shall
 - a. Be accompanied with a Certificate of Analysis (CoA) with Statement of Conformity, from an ISO/IEC17025 accredited lab for the milk to be imported as per the specified requirements (defined in Bhutan Mandatory Regulations or Codex Standards or any other applicable requirements as prescribed by BFDA from time to time).
 - b. Meet the national food labeling requirements.
 - c. Have at least 50% of its shelf life during the time of entry into Bhutan.
 - d. Have evidence that the product is in good regulatory standing from the competent authority in the country of origin.
 - e. Be transported under appropriate conditions.
- 2. The importer shall inform BFDA of any circumstance that may affect the safety and suitability of the milk product.
- 3. The import permit may be revoked where BFDA determines that there is a food safety problem in the country of origin or the manufacturer is no longer in good regulatory standing.
